- PURPOSE: To provide additional information and clarification to the solicitation documents for the above-referenced Project.
- 1. The following information shall become part of the original Request for Proposal (RFP) for this Project.
 - A. The first paragraph of Section III. Notice Request for Proposals is deleted in its entirety and replaced with the following:

"The City of Thornton, CO ("Thornton") respectfully requests separate sealed Proposals for Design Engineering Services for **Cherrywood Park Drainage** *Improvements, Project No.* 21-46B (hereinafter referred to as "Project"). Proposals will be received until 5:00 p.m., local time, June 20, 2022 in the Contract Administration Office, 9500 Civic Center Drive, 2nd Floor City Hall, Thornton, CO 80229-4326."

Please note the intent of the change is to extend the proposal due date to June 20, 2022. Any and all references to the due date found within the request for proposal documents should be understood to be modified as such.

- B. For reference purposes only, the City is providing the Phase III Drainage Report for Cherrywood Park Filing No. 2 dated November 18, 2000. Please note this document is for reference only and is not to be considered a "Contract Document".
- 2. The following questions and answers are provided for additional clarification to the RFP.

Question 1: "The RFP states the cumulative time frame for the project design is 126 Calendar Days. Is this a hard requirement or is there some flexibility?"

- Answer 1: The 126 Calendar Days in the RFP was for planning purposes only. It is not a "hard requirement". Proposing Firms should provide a reasonable and realistic schedule as part of the proposal. There is no hard requirement for the project timeline, but proposing firms should understand the timeline is part of the evaluation criteria.
- Question 2: "Should the design consider any modifications to the existing shade structure or nearby stairs?"
- Answer 2: The City does not believe any modifications of the shade structure are required. However, there may be some alignment modifications at the base of the stairs to accommodate drainage correction solutions.
- Question 3: "Is there currently irrigation available at the empty tree holes?"
- Answer 3: The City believes there is irrigation available, but has not confirmed that to be true.
- Question 4: "Is the field area part of a designed detention area? Does it need to be included as part of a flood mitigation plan?"
- Answer 4: Yes. Cherrywood Park is part of a flood detention area. Proposing Firms should review the drainage report provided with this addendum to better understanding the area drainage and detention issues.
- Question 5: "What are the priorities associated with the drainage for this project?"
- Answer 5: Alleviating the consistent drainage across the sidewalks are the primary concern. Draining the standing pond water on the south side of the park (south end of the sidewalk) and the field drainage are the second and third priorities respectively.
- Question 6: "Will the project require design consulting services through the warranty phase?"
- Answer 6: Yes. The Consultant is expected to provide services throughout the construction of the project to include the warranty phase.
- Question 7: "Should the proposing firms do Geotechnical investigations to determine if the drainage is groundwater?"
- Answer 8: The City believes the drainage is due to groundwater seepage. Proposing firms should assume this to be the case. Geotechnical investigations should be considered as part of the scope post award.
- 3. The Pre-Proposal Conference Minutes to include attendees are attached for additional information.

4. All other terms and conditions shall remain unchanged except as provided by this Addendum. Proposing firms must acknowledge receipt of this Addendum in their Proposal.
