Question 1: Can you give an outline of the budget?

Answer 1: We are not identifying a budget.

Question 2: What is the coordination required of Consultant for bilingual services?

Answer 2: The City of Thornton (Thornton) already contracts with a Spanish translation service and interpreter services.

Question 3: Are you looking for new affordable housing analysis or implementation?

Answer 3: As part of the affordable housing topic, the Consultant will assess and recommend Development Code requirements that help Thornton integrate and obtain more affordable and attainable housing. By way of example, Thornton is looking for recommendations on whether an Inclusionary Housing Program or other required affordability percentages or strategies should be included in the Code and, if so, the Consultant will provide Code language for such requirements. Upon assessment, if the Consultant determines such requirements are not beneficial to Thornton, the Consultant will recommend other Development Code options for increasing the affordable housing supply in Thornton. Thornton last updated its Housing Needs Assessment in 2019 and is not requesting a new assessment or housing analysis as part of this Project.
