- 2. The following questions and answers are provided for additional clarification to the Contract Documents.
 - Question 1: The drawings show 25' of pipe underdrain the bid form has 116' where is the remaining 91' shown and where does it drain to?
 - Answer 1: The pipe underdrain runs under the structure where it connects to the manhole and the outside perimeter of the structure for a total of 116'.
 - Question 2: Can we do a concrete washout pan in leu of the washout area shown?
 - Answer 2: A concrete washout pan is an acceptable substitute.
 - Question 3: Bid form shows (1) manhole but the drawings show (2) manholes. Are we reusing the existing manhole? The note shows to remove. If we are re-using, does the existing manhole have steps?
 - Answer 3: There are two (2) items for manholes on the Bid Form, items 5 and 6, each with a quantity of one (1) each.
 - Question 4: Does the Water line that gets rerouted have valves that can be shut off to isolate that section of the water line so that the water can be shut off during the rerouting of the line and the addition of the fire hydrant, or will other buildings be affected by shutting the water off for the installation of this work? "

- Answer 4: Water shut off(s) will need to be minimized and coordinated with the city as other buildings may be affected.
